No. 8/2015, Cat.No. 1.

It is notified for information of those candidates only **who have downloaded their Admit Cards after 15<sup>th</sup> June, 2016** and their Admit Cards have box Date, Time & Venue of PST will be informed later on on the top of right hand side, that Haryana Staff Selection Commission has fixed Physical Screening Test Schedule starting from **13<sup>th</sup> July, 2016 onwards** at Sector- 4, Umari Road, Near- G.T Road, Kurukshetra for Police Recruitment Male Constable (General Duty) against Advt. No. 8/2015, Cat. No. 1. **Date and Roll No. wise detailed schedule is available on HSSC website i.e [www.hssc.gov.in](http://www.hssc.gov.in).** Only those candidates who have downloaded their Admit Card after 15<sup>th</sup> June, 2016 are advised to report as per their schedule. No other candidates whose roll no. is not mentioned in the schedule available on the Commission's website will be allowed to appear in Physical Screening Test.

- Note-1** The responsibility of having the requisite medical fitness to undergo to this test shall rest upon the candidate (rule 12.16(5) (b) of PPR as amended vide notification dated 8<sup>th</sup> June, 2015 in its applicability to State of Haryana). Therefore, the candidates will participate in the Physical Screening Test at his own risk/responsibility.
- Note-2** Taking drugs and other restricted medicines are strictly prohibited during Physical Screening Test, if any candidate is found consuming/in possession of any drug or other restricted medicine he shall be disqualified from Physical Screening Test.
- Note-3** The candidates are directed to report and register themselves for PST on the schedule date & time available on HSSC website i.e [www.hssc.gov.in](http://www.hssc.gov.in). In case candidates do not follow above schedule they will not be allowed to participate in Physical Screening Test (PST).
- Note-4** Candidates are directed to put their signature and thumb impression on the Admit Card during registration. Candidates failing to do so shall be disqualified.
- Note-5** The Physical Screening Test for candidates belonging to disbanded Haryana State Industrial Security Force (HSISF) is scheduled for 23<sup>rd</sup> July, 2016, at 05.00 A.M, therefore, the candidates belonging to disbanded Haryana State Industrial Security Force (HSISF) are advised to report on 23<sup>rd</sup> July, 2016, at 05.00 A.M.
