They are also directed to bring all original documents, set of attested copies of all documents , one Id Proof and self attested copy of downloaded application form.

2. In case a candidate **does not appear for Scrutiny of Documents**, he/she will not be considered for Viva-Voce/interview and **no further opportunity will be given thereafter**.

3. It is important to note that after the scrutiny of documents, if a candidate is found eligible **it will not confer any right of interview** and candidates only falling within twice the number of vacancies shall be called for interview.

4. Where no post for any reserved category is available, the candidates applying for that particular category have been considered as General Category candidates subject to the fulfillment of all eligibility conditions (except fees) as meant for General Category candidates.

5. While every care has been taken in preparing and uploading the result, possibility of inadvertent/technical errors cannot be ruled out. **The Commission reserves the right to rectify the same later on.**
