c) Walking test of 25 kms for males and 14 kms for females to be completed in four hours.

Important instructions for the candidates

1. Candidates must bring all original certificates with one set of photocopy and downloaded application form with legibly printed Admit Card with recent colored photo pasted on Admit Card duly attested by Gazetted Officer and one identity proof with photo like Driving License, Voter Card, Aadhar Card, Passport etc. at the time of Scrutiny of documents Cum-Physical Measurement Test (PMT) & Walking Test.
2. Taking drugs and other restricted medicines are strictly prohibited during Scrutiny of documents Cum- Physical Measurement Test (PMT) & Walking Test, if any candidate is found consuming/in Possession of any drug or other restricted medicine he shall be disqualified from Scrutiny of documents Cum- Physical Measurement Test (PMT) & Walking Test.
3. The candidates will participate in the Scrutiny of documents Cum-Physical Measurement Test (PMT) & Walking Test at his own risk/responsibility.
4. The candidate can participate in walking test with/without shoe as per his/her choice.
5. The candidates are directed to report and register themselves for Scrutiny of documents Cum- Physical Measurement Test (PMT) & Walking Test on the above given schedule date & time. In case candidates do not follow above schedule they will not be allowed to participate in Scrutiny of documents Cum- Physical Measurement Test (PMT) & Walking Test.
6. Procedure to conduct PST:-
 - i) **Registration of candidate by capturing photographs & biometric finger print after confirming the identity from ID produced by candidate.**
 - ii) **Providing separate chest number & RFID tags**
 - iii) **The candidates are required to pass through all the points of runway and if a candidate's chip is not recorded at any point, He/she shall be declared fail.**
 - iv) **De-registration, obtaining Bio-metric and taking back RFID chip & chest number at end of race/walking test.**
7. In case a candidate does not appear for Scrutiny of documents Cum-Physical Measurement Test (PMT) & Walking Test he/she will not be considered for Viva-Voce/interview and no further opportunity will be given thereafter.

Admit Card for Scrutiny of documents Cum- Physical Measurement Test (PMT) & Walking Test of the candidates will be uploaded on the Commission's

Web-site i.e. www.hssc.gov.in. The candidates can download the admit cards from the Commission's Web-site from **27.01.2019 onwards**. Thereafter Link for download of Admit card will be disabled. No other chance will be given to download admit card later on. Candidates are advised to read the instructions on the Admit Card carefully and follow the same strictly. Request for change of date of Scrutiny of documents Cum- Physical Measurement Test (PMT) & Walking Test will not be entertained by the Commission.

Separate call letters/intimation will not be sent to the candidates by the Commission through post.
