They are also directed to bring all original documents, set of attested copies of all documents, self attested copy of downloaded Application Form and filled scrutiny form. Scrutiny form is to be downloaded from website and to be submitted at the time of scrutiny along with documents.

2. It is important to note that after the scrutiny of documents, if a candidate is found eligible it will not confer any right of interview and candidates only falling within twice the number of vacancies above shall be called for interview. Candidates who have already been interviewed will not be interviewed again.

3. No further opportunity for scrutiny will be given. Candidates shall be responsible themselves if they choose to remain absent for scrutiny. Candidature of all absentee candidates will be cancelled and no representation in this regard will be entertained.

4. While every care has been taken in preparing and uploading the Roll No. of Candidates for Scrutiny of Document, possibility of inadvertent/technical errors cannot be ruled out. The Commission reserves the right to rectify the same later on.
