2. The matter regarding JRN University candidates is sub-judice before Hon'ble High Court in various CWP No. 24996/2021,1989/2022,5822/2022,5877/2022,24125/2021,27175/2022,27058/2022 , 23722/2021 and 23467/2021 and present result would also be subject to the final outcome of these writ petitions.

3. Result of petitioner namely manpreet kaur bearing roll no 2660008074 in CWP No. 6789/2021 is being kept in sealed cover.

4. The present result will be subject to any litigation pending before any competent court.

5.While every care has been taken in preparing and uploading the result, possibility of inadvertent/technical errors cannot be ruled out. The Commission reserves the right to rectify the same later on.
