## NOTICE TO CANDIDATES FOR POLICE RECRUITMENT MALE CONSTABLE (GENERAL DUTY)

### (PHYSICAL SCREENING TEST)

Whereas Physical Screening Test for the post of Male Constable (General Duty) against Advt. No. 8/2015, Cat. No .1 is being held at **Sector-4, Umari Road, Near G.T. Road, Kurukshetra.**

And whereas in the notice to the candidates issued on 21<sup>st</sup> March, 2016 published in various newspapers and also published on Commission's web-site i.e www.hssc.gov.in for Physical Screening Test information for download of Admit Card mentioning that:-

1. Taking drugs and other restricted medicine are strictly prohibited during Physical Screening Test.
2. The candidate will participate in the Physical Screening Test at his own risk/responsibility.

And whereas it has been also mentioned in the Admit Card that:-

1. शारीरिक स्क्रीनिंग परीक्षा में मौके पर दी जाने वाली या तय की गई हिदायतों व मापदंड की पालना ना करने वाले उम्मीदवारों की उम्मीदवारी रद्द कर दी जायेगी।
2. And an undertaking is being obtained as under:-

मैं पुरुष कांस्टेबल पद पर भर्ती हेतु हरियाणा कर्मचारी चयन आयोग द्वारा आयोजित शारीरिक स्क्रीनिंग परीक्षा में भाग लेने हेतु/शारीरिक/मानसिक रूप से पूर्णतया स्वस्थ हूं तथा इस परीक्षण के लिए मेरे द्वारा किसी प्रकार का उतेजक/मादक/प्रतिबंधित दवाओं का सेवन नहीं किया गया है। शारीरिक स्क्रीनिंग परीक्षा में मैं स्वेच्छा से भाग ले रहा हूं तथा इसके दौरान होने वाले किसी भी प्रकार की हानि/क्षति/शारीरिक चोट के लिये मैं स्वयं जिम्मेवार हूं।


And whereas on the Notice Board on the PST site also it is mentioned that:-

1. Taking drugs and other restricted medicine are strictly prohibited during Physical Screening Test.
2. The candidate will participate in the Physical Screening Test at his own risk/responsibility.

In spite of above, it has come to notice that certain candidates are using/taking drugs and certain untoward incidents due to consumption of drugs has also come to notice. Now it is hereby again announced/published for the candidates in particular and public in general that no candidate should take any kind of drugs etc. before Physical Screening Test and if it is found that he has consumed any drug his candidature is likely to be cancelled. Further the candidates should participate in Physical Screening Test at his own risk and the Commission shall not be responsible for any kind of injury physical or mental etc. caused to the candidates during the test.

Parents of the applicants are also advised to instruct their wards not to take any kind of drugs before or during Physical Screening Test.
