**The candidates are strictly advised to bring all original certificates/documents while attending interview along with following documents otherwise interview will not be conducted:-**

1. Interview will be conducted of only eligible candidates after verification/scrutiny of documents.
2. Candidates to bring downloaded application form and original certificate/diploma/degree from matriculation onwards, experience certificate with salary and date of issue (if so required as per advertisement) PHC/OSP/EBPG/Caste/Haryana Resident certificate, DESM Eligibility Certificate, ESM discharge book etc. for verification along with photocopy of each on or before cutoff date of the said advertisement.
3. Proof of date of birth.
4. Original Commission's copy of proof of fee.
5. No second chance will be given to the absent candidates. No further correspondence will be entertained in this regard.
6. Mere issuance of Admit Card does not entitle a candidate to take his/her interview. Candidature of the applicant is provisional subject to his/her fulfillment of eligibility condition on cutoff date as per condition of advertisement.
7. If at any stage it is detected that a candidate does not fulfill the requisite qualification prescribed for the post till the last date of submission of application form, or is ineligible on any other ground, his/her candidature will be cancelled.
8. DESM candidate will bring Self Declaration to the effect that he has not seized to be a DESM till today or any other member of his family has not taken benefit of DESM in Govt. Services.
9. Interview will be held of those candidates who have qualified for interview as per result dated 07.05.2016.
10. Use of mobile, pager and other electronic/communication devices is strictly prohibited during the process of verification/scrutiny of documents-cum-interview. If any candidate is found in possession of mobile phone or any other electronic gadget, his/her candidature will be cancelled.
11. The attendance in the interview will be marked using Bio-Metric Attendance process by capturing the thumb impression.
