4. It is important to note that after the scrutiny of documents if a candidate is found eligible it will not confer any right of interview and candidates only falling within twice the number of vacancies above shall be called for interview.

5. In case of Deputy Ranger of Forest Department against advt. No. 12/2015 Cat No.11, before the interview/viva-voce the candidates will have to qualify the Physical Standards and walking test as per advertisement conditions and relevant service rules.
