2.The result of SBC/BC(C) category has been withheld as per letter no. 42/187/2015-5GSI Dated:25.08.2016 issued by chief secretary, Government of Haryana in view of directions of the Hon'ble High Court that no appointments in service shall be made on the basis of the provision of the Haryana Backward Classes (Reservation in services and admissions in educational insitutions) Act 2016 to the castes mentioned in schedule-III i.e. Backward Class Block 'C'. The SBC/BC(C) Category candidates,except those who have availed the benefit of age relaxation,have been considered against general vacancies.

3. As per Govt. Instruction no 22/15/1992-3GS III Dated: 07.10.2008, if suitable candidates of Outstanding Sports Person are not available in a particular category, then the vacancies have been filled up from amongst the same category candidates.

4. As per Govt. Instruction no 22/10/2010-1GS III Dated: 23.05.2014, if suitable candidates of Ex-Servicemen are not available in a particular category, then the vacancies have been filled up from amongst the same category candidates

5. While every care has been taken in preparing and uploading the result, possibility of inadvertent/technical errors cannot be ruled out. The Commission reserves the right to rectify the same later on.
