NOTE:-1. Selection of all above candidates is subject to the Socio-economic marks verification and other qualification by the department, if candidate is found taken fake/false benefit of Socio-economic criteria, then he/she will be ousted from the selection list and candidature may also be cancelled. All candidates are intimated to produce & submit certificate issued by Tehsildar/Executive Magistrate/SDM regarding 'No Govt. job in family' under socio-economic criteria at the time of joining to department.

2. As per Govt. Instruction no 22/15/1992-3GS III Dated: 07.10.2008, if suitable candidates of ESP are not available in a particular category, then the vacancies be filled up from amongst the same category candidates

3. As per Govt. Instruction no 22/10/2010-1GS III Dated: 23.05.2014,if suitable candidates of Ex-Servicemen are not available in a particular category, then the vacancies be filled up from amongst the same category candidates.

4. "01 post of HH Category shall be carry forward due to nonavailability of suitable candidates.
