Further, in compliance of Hon'ble Punjab and Haryana High Court order passed in various pending writs before any court of law, the petitioners are also called for Interview/viva-voce on **02.03.2019** for the post of Mandi Supervisor-cum-Fee Collector, Accountant(M.C.) and Auction Recorder of Haryana State Agriculture Marketing Board (HSAMB) against Advt. No.7/2015, Category No.17, 18 & 19.

4. The Candidates are also directed to bring all original documents, downloaded application form, along with one set of self attested copies of all documents mentioned in their application form and One ID proof. The notice is also available on the web-site **www.hssc.gov.in** of the Commission.

5. In case a candidate does not appear for Scrutiny of Documents and Interview/Viva-Voce, **no further opportunity will be given thereafter.**
