Relaxation in age to ad hoc/contract/work-charged/daily wages/outsourced employees to make them eligible to compete for regular recruitment.

Sir/Madam.

I am directed to invite your attention on the subject noted above and to say that Hon'ble High Court in a case CWP 17206 of 2014 titled Yogesh Tyagi and another Versus State of Haryana and others, have directed to grant relaxation in age to the persons who have worked continuously on ad hoc/contract/work-charged/daily wages basis in any Department/ Board/Corporation of Haryana Government to make them eligible to compete for regular recruitment.

- In view of this, the State Government has decided to grant relaxation in maximum age to the persons who have already worked or are presently working on ad hoc/contract/workcharged/daily wages/under outsourcing policy in any Department/ Board/Corporation of Haryana Government to make them eligible to compete for regular recruitment. This relaxation in maximum age will be admissible equal to the period he has worked on ad hoc/contract/work-charged/daily wages/under outsourcing policy excluding the period of break, if any, for appointment to a post on regular basis through Haryana Staff Selection Commission, Haryana Public Service Commission or any other Recruitment Agency etc. in any Department/Board/Corporation of Haryana Government.
- It is clarified here that once a person is selected for regular appointment availing benefit of relaxation in age, he/she will not be entitled to avail such benefit again for subsequent appointment to any post.

These instructions may please be brought to the notice of all concerned.
