Notice for Selection Criteria of Law Officer (CB)

Reference this Commission Adv. No. HSSC/IE/2022/6597 Cat.-1 for Engagement of Law Officers purely on contractual basis published on 04.08.2022 on our website www.hssc.gov.in. Selection criteria for engagement of Law Officer on contractual basis has been notified as follows :-

| i) | Written Test | 100 marks |
| ii) | Experience in concerned field | 05 marks |
| iii) | Interview and Skill Test | 20 marks |

(I) Details of Written Test

Commission shall make selection of candidates on the basis of merit in written examination, experience and Interview-&Skill test criteria. Written Test comprising of 100 multiple choice questions with one mark for each correct answer shall be as follows:

- i) **50% weightage for Law questions** : i.e. a) Constitution of India (b) CPC (c) Cr.P.C. (d) Limitation Act and (e) Service Law etc.
- ii) **20% weightage** for English language consisting of general English & grammar question.
- iii) **10% weightage** for Hindi language consisting of General knowledge of Hindi & grammar.
- iv) **10% weightage** for History, Haryana Culture Knowledge, Current Affairs.
- v) **10% weightage** for Reasoning and General Knowledge.

(II) Experience

Experience in concerned field:	Experience above 3 years- @ ½ mark per completed year (maximum 3 marks)
Experience in concerned field in Govt/Centre Govt. recruiting agencies, if any.	(@ ½ mark for completed year, maximum 2 marks)
Total	5 Marks

05 marks have been kept for Experience which will be as under :-

(III) Interview and skill test :


20 marks have been kept for interview-&-skill test of candidates. On the merit list of written test, three times candidates will be called for Scrutiny of documents and interview-&-skill test. Marks for experience shall not be counted at this stage. All bracketed candidates with same cut off marks shall be called for interview-&-skill test. At first, Original certificates of qualifications and experience documents will be scrutinized as per condition of advertisement. After scrutiny of document, Skill test of eligible shortlisted candidates will be conducted which shall be of **10 marks**. Same shall be conducted to ascertain the knowledge in drafting skills of candidate essential for defending/filing of applications/replies before the Hon'ble High Court in recruitment cases. All the above candidates will further be required to appear before the Committee for further interview which will be of **10 marks**. Marks for experience shall be considered while finalizing selection after interview and skill test.

Total selection criteria for merit list :

125 marks

Instructions:

1. The decision of the Commission in all matters relating to acceptance or rejection of an application, eligibility of candidate, mode of and criteria for selection etc. will be final and binding on the candidates.
2. No inquiry or correspondence will be entertained in this regard. HSSC reserves the right to increase or decrease the number of vacancies on administrative ground.

If in Scrutiny or verification at any stage starting from submitting application till engagement, it is found that any candidate does not fulfill any of the eligibility condition or it is found that information furnished is false or incorrect, his/her candidature will be cancelled and further action, which Commission think appropriate, will be taken against the candidate.
