For and on behalf of the Haryana Staff Selection Commission, Panchkula, Etenders are invited from established and reputed firms/agencies registered with the Labour Commissioner, Haryana and also having ESI/EPF/PPF, GST and PAN/GIR Nos. from the concerned department of the Government for providing services of various categories of manpower having work experience of minimum two years for the activity. If a tenderer does not mention ESI, PF, PAN and GST No. in his technical bid, he shall not be considered and shall be deemed to be ineligible. The tender shall include Technical and Financial Proposal. The financial proposal for each activity should be subscribed with the name of activity and technical & financial bid is given in separate sealed covers. Detail of activity is given below in table:-

The e-tender for activity mentioned above should be addressed in favour of the Secretary, Haryana Staff Selection Commission, Panchkula. The terms and conditions of the tender are as under:-

TERMS & CONDITIONS:-

1. The eligible interested Contractor/Agency/Firm may submit tenders, mentioning therein eligibility, photocopies of various registration certificates (EPF, ESI, Labour and Police), and evidence of adequacy of working capital for this contract, past experience and performance certificates from other government departments etc., for all the posts mentioned above. All the documents/papers attached with tender document must be countersigned/attested by the signing

authority of the Contractor/Agency/Firm. Contractor/Agency/Firm must have service tax registration number alongwith PAN number issued by the Income Tax Department. The firms are required to mention the service charges in their quotation which will be charged by them over and above the rates fixed by Haryana Government vide letter No. 16/7/2015-1GS-II, dated 6th April, 2015. The firm will have to provide the facility of EPF and ESI to the workers engaged by them during the period of contract. Guidelines/Instructions issued by the Government of Haryana from time to time will be strictly followed by the agency. Conditional tender will not be accepted. Validity of tender is one year.

- 2. Earnest money of Rs. 1,00,000/- (Rupees one Lakh only) through online payment on or before 03.02.2020 upto 05.00 PM
- Minimum annual turnover of firm should be Rs. 50.00 lakh (Fifty Lakh only) for last three consecutive financial years.
- 4. The firm whose tender will be accepted shall also be required to deposit a security amount of Rs. 2,00,000/- (Rupees one Lakh only) in favour of Secretary, Haryana Staff Selection Commission, Panchkula in the form of bank guarantee which may be forfeited by Commission in the event of not carrying the work as per term & conditions of agreement.
- 5. The Technical bid shall be opened first on the scheduled date and time i.e. 04.01.2020 at 02.00 P.M. in the office of the Secretary, Haryana Staff Selection Commission, Bays No. 67-70, Sector-2, Panchkula on the spot at that time. Technical Bid shall be evaluated by the Committee constituted for the purpose. Necessary clarification required by the Committee shall be furnished by the Tendered within the time given by the Committee for the same. Financial Bids of technically qualified/eligible bidders, meeting the entire requisite criterion, only shall be opened on the scheduled date and time fixed by the Commission.
- 6. In case, the date fixed for opening of Bids is subsequently declared as holiday by the Government, the Bids will be opened on next working day, however, time and venue remaining unaltered.
- 7. The Bidder shall quote the Technical and Financial Bids strictly as per the format enclosed at Annexure I and II.

- 8. Each Contractor/Agency/Firm shall submit only one tender. A contractor who submits more than one tender will be disqualified.
- 9. The manpower to be provided by the agency shall always remain the employee of the agency for all intents and purpose and the Service Contractor/Agency/firm shall alone be liable for any dispute amongst their employees and the agency, which may arise in any court of law. The Haryana Staff Selection Commission shall under no circumstances be deemed or treated as the employer of the person engaged for any purpose. The services of the person so engaged shall hereafter cease on the expiry of the term without providing him any claim for the regularization of series or any other consequential benefit.
- The Contractor/Agency/firm shall not employ any person below the age of 18 years.
- 11. The contract shall automatically expire after one year unless extended further by the office.
- 12. Administrative/ Service charges @ 2% value or less straightway rejected. Service charges will be paid on D.C. rate / Basic wage rate excluding EPF/ ESI. No more than two digits will be valid after decimal values for service charges (e.g. 0.00).
- 13. In case of equal service charges quoted by the agencies, the committee constituted for this purpose will have the right to select the service provider on the basis of turnover, work experience, manpower available with the agency and activities of the firm/agency.
- 14. The Contract/Agency/firm shall be responsible for the attendance of his staff in Haryana Staff Selection Commission. In case of any staff of the Contractor/Agency/firm remains absent or granted leave, Contractor/Agency/Firm will sent/arrange his substitute for the absence period.
- 15. The contractor/Agency/firm will have to produce the register of wages or he register of wages-cum-muster roll of the preceding month along with the bill to be submitted on the 5th day of every calendar month for verification to the nominated official, nominated for this purpose by the Secretary, Haryana Staff Selection Commission, Panchkula. The agency will pay wages as per rates fixed by Haryana Government vide letter No. 16/7/2015-1GS-II, dated 6th April, 2015 and

- disburse the wages in the form of account payees cheque/NEFT/ RTGS to the employees recruited by it on or before 7th of each month.
- 16. The Contractor/Agency/Firm shall deduct Provident Fund of manpower engaged by the Contractor/Agency/Firm, both employee's as well as employer's share and will deposit the same with the concerned authority well within the specified date. The Contractor/Agency/Firm will deposit the challan/receipt in the O/o Secretary, Haryana Staff Selection Commission. The Commission will not be responsible on any part of this kind. Wages, if worker will be same as fixed by Haryana Government vide letter No. 16/7/2015-1GS-II, dated 6th April, 2015.
- 17. EPF, ESI, Service Tax and Service Charges are payable on the rate fixed by Haryana Government vide letter No.16/7/2015-1GS-II, dated 6th April, 2015. The TDS shall be deducted as per the provisions of Income Tax Department, as amended from time to time and certificate to this effect shall be provided to the Contractor/Agency/Firm by this office.
- 18. The Agency will submit the copies of challans, pertaining to ESI and Goods Service Tax deposited, showing the individual figure of deposit for the previous month alongwith remuneration bill. The payment to the agency will be released after seeking.
- 19. The Contractor/ Agency/ Firm shall issue identity cards, on its own name, to its personnel deputed for rendering the said services, which would be subject to verification at any time. The institution may refuse the entry into its premises to any personnel of the contractor not bearing such identity card.
- 20. The outsourcing policy for engaging/ outsourcing of services issued by Government from time to time will be strictly followed by the agency.
- 21. The Contractor/ Agency/ Firm will have to observe/comply all the rules and regulations and Govt. Instructions pertaining to EPF, ESI and labour Laws, as applicable from time to time. In case, the tendering agency fails to comply with any statutory/Taxation liability under appropriate law, and as a result thereof this office is put to any loss/obligation, monitory otherwise, this office will be entitled to get itself reimbursed out of the outstanding bills and the security deposit of the agency, the extent of the loss or obligation in monitory terms.

- 22. The Contractor/Agency/Firm engaged shall pay wages to its employees, as prescribed in the agreement, by way of account payee cheque/bank draft/NEFT/RTGS pay order. In case of default in this regard or any other deficiency/default in providing service, the agreement will be terminated by giving fifteen days notice by forfeiting the security amount deposited for this purpose.
- 23. Details agreement for the purpose including penal clauses shall be executed after terms and conditions.
- 24. The rates quoted should specify whether the same are inclusive of all services taxes.
- 25. Bill shall be submitted by the agency immediately after the month is over but not later than seven days in any case.
- 26. In case of any litigation the jurisdiction will be at Panchkula. In case of any dispute arising under the contract/agreement, the same shall be referred to the sole arbitrator appointed by Chairman, Haryana Staff Selection Commission. He/she may be the employee of Haryana Staff Selection Commission and the award of the Arbitrator shall be final and binding on the parties to the contract/agreement. The venue of Arbitration will be Panchkula and the proceeding of Arbitrator may be in English or Hindi.
- 27. The service provider, who shall succeed will not disclose the confidentiality of activity (examination process) and anything related thereof to anyone except only after the proper approval of the Commission and a non-disclosure undertaking shall have to be submitted to the Commission on the stamp papers.
- 28. The Commission reserves the right to reject/cancel/withdraw the tender without any reason at any time.
- 29. Earnest money deposit will not carry any interest. The EMD deposited by unsuccessful bidder/tender will be refunded as soon as possible. EMD of successful tenderer will be refunded after successful tenderer finishes the agreement successfully.
- 30. The contract/agreement will be governed by the applicable law in India for the time being in force.
