





**E-TENDER NOTICE**

For and on behalf of the Haryana Staff Selection Commission, Panchkula, E-tender is hereby invited for empanelment on non-exclusive basis for execution of **Biometric Attendance with Device and Manual Biometric on the Attendance sheet & OMR etc., Frisking, Videography of candidates, CCTV Camera with live streaming/without live streaming, Physical Screening Test (PST) and Physical Measurement Test (PMT)** from corporation/companies/ firms/ societies and agencies of repute, having sufficient work experience of minimum three years for holding examinations or similar activities etc. on at least 350 centres in Central Government, State Government/Semi Government/Board/ Corporation/ Universities/Public Undertaking/ recruitment agencies, Universities and any reputed/Private Institutions for the activity mentioned below. The tenderer should have ESI, PF, PAN and GST No. which should be mentioned in the technical bid. If a tenderer does not mention these in his bid, he shall not be considered and shall be deemed to be ineligible. The examination can be held anywhere in the State of Haryana, Delhi and Chandigarh. The number of students may vary from hundreds to lakhs and there will not be minimum guaranteed numbers of candidates. The tender shall include Technical and Financial Proposal. The financial proposal for each activity should be subscribed with the name of activity and technical & financial bid be given in separate sealed covers. E-tender for above activities should be addressed in favour of the Secretary Haryana Staff Selection Commission, Panchkula. Agency should be quoted the rates as per admit card for activities mentioned at sr. no. 1 and 5. For sr. no. 2 rates should be quoted as per number of CCTVs at the entrance and classrooms with/without live streaming as per requirement. Regarding activity at sr. no. 1, rates of biometric with and without item no (v) (i.e. online capturing & accessibility) be given separately. Rates for activities at sr. no. 3 & 4 should be quoted as per admit card generated and per person deployed at centre with video camera/device separately.

**TERMS & CONDITIONS:-**

- The firm should submit their rates along with Earnest Money Deposit (EMD) of Rs. 2,00,000/- (Rupees two lakhs only) as earnest money deposit for above mentioned each activity in favour of Secretary, Haryana Staff Selection Commission, Panchkula. The firm shall submit E- tender duly typed (in English) in prescribed format.
- Conditional offer and/or offers without earnest money deposit (EMD) will not be considered and there will be no relaxation in any case for any reason. The negotiation at the time of opening of tender can be considered, if required. Before allocating/ assigning the work the technical, specifications, viability, the credibility, efficiency and financial soundness etc. of the firm/bidder will be considered.
- The Commission reserves the sole right of accepting the whole or any part of the E-tender of above mentioned activities. No claim for compensation or otherwise whatsoever will be entertained by the Commission.
- The firm whose tender will be accepted shall also be required to deposit a security amount minimum of Rs. 10,00,000/- (Rupees ten lakh only) for each activity in favour of Secretary, Haryana Staff Selection Commission, Panchkula in the form of bank guarantee and shall be

increased upto 10% of the total amount of the bill which may be forfeited by Commission in the event of not carrying the work as per terms & conditions of agreement.

5. The firm should have their own infrastructure/efficient staff, machinery etc. for handling the above mentioned activity and intimate the total capacity of instruments available with them along with its details i.e. name of Company, capacity and other technical details.
6. The firm shall have to depute at least one coordinator/manager in each district of examination and one team leader for maximum ten centers. The Manager shall be permanent employee and other person may be empanelled by the tenderer after verifying their antecedents. No person deputed shall be less than 12th qualification. The district-wise details of coordinators and team leaders with centre number shall be shared with Commission 10days before the exam and they shall coordinate with team of HSSC one day before the exam. Agency should provide centre wise details of the persons employed/engaged which include their Aadhar Card No., Mobile No., Permanent Address etc. to the commission in advance as and when demanded by the Commission to establish the identity of the persons. Commission can also ask to change the staff to the agency in case of any exigency. Agency will also provide the hard/soft copy of the above details to the Commission along with Bill.
7. Agency will have to follow the labour laws as applicable and Commission is not responsible for any violation thereof. In case of any Court case arising due to violation of any condition/labour law, the Commission is not responsible for that and agency to handle the dispute at its own level.
8. If any FIR is lodged then the agency shall fully cooperate with the Commission as well as with the investigating agency at his own expense along with all legal expense to be recovered from Agency.
9. In case of any litigation the jurisdiction will be at Panchkula. In case of any dispute arising under the contract/agreement, the same shall be referred to the sole arbitrator appointed by Chairman, Haryana Staff Selection Commission. He/she may be the employee of Haryana Staff Selection Commission to which the tenderer shall not have any objection and the award of the Arbitrator shall be final and binding on the parties to the contract/agreement. The venue of Arbitration will be Panchkula and the proceeding of Arbitrator may be in English or Hindi.
10. The firms shall execute the agreement within a week after allotment of Tender/ Work. The firm which will succeed shall have to set a local branch office in (Chandigarh or Panchkula) for execution of the work at the time of examination and work allotment within 15 days.
11. The service provider, who shall succeed will not disclose the confidentiality of activity (examination process) and anything related there to anyone except only after the proper approval of the Commission and a non-disclosure undertaking shall have to be submitted to the Commission on the stamp papers.
12. Tender will be opened in two stages i.e. first-Technical Bid & Second-Financial Bid. Technical Bid shall consist of complete demo of the activity along with instruments used for which tenderer is submitting tender, which shall be considered first, and if the same is found satisfactory, thereafter Technical Bid shall include the demonstration of apparatus used, technical viability and also specify the number of candidates, number of centers and number of cities in Haryana for which the tenderer can give service and time taken for the activity to be performed. After acceptance of technical bid the Financial Bid shall be opened. Financial Bid


will be finalized through e-tender system only and negotiations may be done by the Commission.

13. The Commission does not assure of minimum quantum of work during the tenure of contract/agreement to the successful tenderer.
14. The Commission reserves the right to reject/cancel/withdraw the tender without any reason at any time.
15. Any request to adjust earnest money deposit out of tenderer's running bills or pending payments with commission will not be considered.
16. Earnest money deposit will not carry any interest. The EMD deposited by unsuccessful bidder/tender will be refunded as soon as possible. EMD of successful tenderer will be refunded after successful tenderer finishes the agreement successfully i.e. after agreement period.
17. All tenders will be kept valid for acceptance for 90 days from the tender closing date.
18. Delivery of proper service of activity will be the essence of contract/agreement. In case of delay and not delivering the service as per agreement, the Commission reserves the right to penalise or cancel the contract/agreement wholly or partially and make alternative arrangement at the risk and cost of the service provider with a notice of three day to the firm.
